NOTICE OF INTENT FORM

1. Submit a complete and accurate description of the precinct you wish to restrict.

The description of the precinct boundaries of the 13 Precinct of the 11 Ward of the City of Chicago in the County of Cook and the State of Illinois, as such precinct existed as of the last General Election, is as follows:

Beginning at the intersection of S. Halsted St. and W. 43<sup>rd</sup> St., thence east on W. 43<sup>rd</sup> St. to S. Wallace St., thence south on S. Wallace St. to W. 44<sup>th</sup> St., thence east on W. 44<sup>th</sup> St. to S. Wallace St., thence south on S. Wallace St. to W. 46<sup>th</sup> St., thence west on W. 46<sup>th</sup> St. to the alley east of S. Union Av., thence south on said alley to W. 46<sup>th</sup> Pl., thence west on W. 46<sup>th</sup> Pl. to S. Union Av., thence south on S. Union Av. to W. 47<sup>th</sup> St., thence west on W. 47<sup>th</sup> St. to S. Halsted St., and thence north on S. Halsted St. to the place of beginning.

2. Please select the scope of restriction sought for the 13 Precinct of the 11 Ward:

A: Restricting Shared Housing Units and Vacation Rentals


# PCT 13 WARD 11
