**INSTRUCTIONS FOR COMPLETION AND SUBMISSION
OF THE NOTICE OF INTENT FORM:**

PLEASE NOTE: The Notice of Intent Form can be found on Page 4 of this packet or on www.chicityclerk.com/houseshare

1. **Submit a complete and accurate description of the precinct you wish to restrict.** The *Notice of Intent* must correctly: (i) identify the precinct number and Ward to be restricted, and (ii) describe the complete legal boundaries of the precinct as the precinct existed on the date of the last General Election.

If the Petitioner is **unsure of their Ward or precinct number** the Petitioner may obtain this information by:

- Referencing their Illinois Voter Registration Card; OR
- Contacting the Chicago Board of Elections at www.chicagoelections.com

If the Petitioner is **unsure of their precinct's legal boundaries:**

- The Office of the City Clerk may assist the Petitioner in identifying the precinct's boundaries; OR
- The Petitioner may obtain this information by contacting the Chicago Board of Elections at: <http://www.chicagoelections.com/en/ward-maps-and-aldermen.html>

If the Petitioner is **unsure whether their precinct contains residentially zoned property (Note: zone must contain an RS1, RS2, or RS3 designation to qualify):**

- The Petitioner may obtain this information by viewing the Chicago Zoning and Land Use Map at: gisapps.cityofchicago.org/ZoningMapWeb/; OR
 - In certain instances, the Office of the City Clerk may assist the Petitioner in identifying whether the precinct contains residentially zoned property.
2. **Select the scope of the restriction.** Check the box of the desired restriction. Only one restriction can be selected per *Petition* (see Page 2 for restriction type definitions).
 3. **Submit the completed *Notice of Intent Form* IN PERSON to the City Hall Office of the City Clerk, located at 120 North LaSalle Street – Room 107, Chicago, IL 60602.**

TYPES OF RESIDENTIAL RESTRICTIONS EXPLAINED

Prior to circulating a *Petition* to create a ***Restricted Residential Zone*** in a precinct that contains residentially zoned RS1, RS2 or RS3 property, the Petitioner must first identify the nature of the restriction being sought. Chapter 4-17 of the Municipal Code of Chicago authorizes six options for establishing a ***Restricted Residential Zone***, each of which are described below. The Petitioner must pick **only one** of the six options. Depending on the option chosen by the Petitioner, the City Clerk has prepared an appropriate *Petition* to reflect that option.

PETITION OPTIONS¹

Option #1: “Petition restricts *all new or additional shared housing units AND vacation rentals* within the precinct.”

Option #2: “Petition restricts *all new or additional shared housing units* within the precinct.”

Option #3: “Petition restricts *all new or additional vacation rentals* within the precinct.”

Option #4: “Petition restricts *all new or additional shared housing units AND vacation rentals* within the precinct that ARE NOT their owner’s or tenant’s primary residence.”

Option #5: “Petition restricts *all new or additional shared housing units* within the precinct that ARE NOT their owner’s or tenant’s a primary residence.”

Option #6: “Petition restricts *all new or additional vacation rentals* within the precinct that ARE NOT their owner’s or tenant’s a primary residence.”
