Pursuant to Rule 41 of the City Council Rules of Order, I hereby give notice that at the City Council meeting to be held on Tuesday, November 24, 2020, I intend to call for a vote on the following items, which are expected to be reported out of committee by the Committee on the Budget and Government Operations and the Committee on Finance and deferred and published at the November 23, 2020 City Council meeting:

Committee on the Budget and Government Operations

1. A series of amendments to the 2021 Budget Recommendations.
2. The 2021 Annual Appropriation Ordinance, as amended.
3. A resolution amending the Regulations Governing the Administration of the Classification Plan and Employee Benefits for Classified Positions set forth in the Annual Appropriation Ordinance (2021 Salary Resolution – R2020-864).
4. An ordinance approving an Intergovernmental Agreement with Chicago Transit Authority and Cook County for the allocation of Motor Fuel Tax funds to Chicago Transit Authority as Year 2021 matching grant pursuant to Regional Transportation Authority Act (O2020-5744).
5. An ordinance concerning expenditure of portion of the Motor Fuel Tax funds allocated to the City of Chicago for Year 2021 (O2020-5745).
6. An ordinance amending various Municipal Code provisions (2021 Municipal Code Corrections Ordinance – O2020-5718).
7. An ordinance amending various Municipal Code provisions concerning departmental functions and duties (2021 Management Ordinance - O2020-5746).

8. An ordinance authorizing the levy of real estate taxes for the City of Chicago for the year 2021 (O2020-5747). Amount of Tax Levy: \$1,632,926,000.

9. An ordinance authorizing the City of Chicago to issue general obligation bonds and additional sales tax bonds for various purposes and the levy and collection of direct annual taxes (O2020-5749).
10. An ordinance amending various Municipal Code provisions concerning revenue derived from certain taxes, fines and fees (2021 Revenue Ordinance – O2020-5743).
